

The 9th BenQ Materials Potential Talent

Scholarship Regulations

一、Objective.

BenQ Materials is committed to the research and development of innovative materials science as well as diversified products and market applications with optics as the starting point for R&D technology. In order to cultivate talents in professional fields, we have established a scholarship for potential talents to encourage students to engage in research and marketing in related fields, so that they can fully utilize their expertise and promote the development of industries in the future, and contribute to the Taiwan society.

二、Scholarship Program.

(A) Research and development of science and technology group.

1. Master's degree students: science and technology-related disciplines; optical and electrical, materials, chemical, chemical, information technology, and polymer disciplines are desirable.
2. PhD students: PhD II or above, and the thesis and research area should be related to battery materials, chemical and chemical materials, big data, optoelectronics and other technologies.
3. If the recipient is not a fresh graduate, the recipient will be required to do an internship in the company and the internship salary will be separately approved.
4. Awardees who have plans to continue their education will be deferred until they obtain a new degree with the approval of the company.

三、 Auditing Standards and Implementation Procedures

1. Preliminary examination: written information review; no further notice for those who fail to pass. (Please refer to the attached document for review)
2. Review: Students who pass the initial screening will be arranged for a physical or online interview.
3. Acceptance Announcement: Students are scheduled to be announced on [BenQMaterials Career FB](#) in November.
4. Award ceremony: The winner will be notified of the award information later, and the winner must come to the company to receive the commendation and certificate, and sign the "BenQ Material Potential Scholarship Contract", otherwise it is regarded as giving up.
5. Scholarship payment: The scholarship is expected to be paid in the III-2 semester and will be paid according to the average of the remaining semester of the recipient; for recent graduates, the outstanding balance of the scholarship will be provided after their employment, please refer to the table below.

四、Co-eligibility.

1. Academic and operational grades of at least 85 (GPA 3.7 or higher) in the previous academic year.
2. Additional points will be given to those who have a low to moderate income, single parent, or a parent who is seriously ill and incapable of working.
3. Those who have not received scholarships from other companies that require tied services.

五、Application time and operation.

1. Application Period: From now until October 15, 2022.

六、Caution.

If one of the following circumstances occurs to the recipient, BenQ Materials may release all scholarship rights and the student shall return the scholarship received.

1. Awardees are not allowed to work (either full-time or part-time) in other companies, institutions or any organizations or perform research and development alternative service during their academic or military service without the consent of BenQ

Materials.

2. If the recipient does not report to school within 30 days after graduation, he/she will be asked to return the full amount of the scholarship.

(Except for those who have been agreed by BenQ Materials)

3. Mid-term dropout (including any reason for leaving school) or the expiration of the legal academic year is still unable to graduate; but by the school's teaching unit or Mingji materials agree to the reasons for its suspension, and the period of suspension is not more than one year, except for this limit.
4. Students who violate the law or school rules, behave in a manner contrary to good customs, do not participate in normal teaching activities, or behave in a manner that may damage the reputation of the school or Ming Kei materials, and do not improve after counseling.
5. Winners will be disqualified if their application documents do not match the facts.
